The COTABATO ELECTRIC COOPERATIVE, INC. (COTELCO), *through* Bids and Awards Committee (BAC), invites Eligible Bidders to apply for eligibility and to bid for the hereunder contracts:

1. Bids received in excess of the ABC shall be automatically rejected in bid opening.
2. Bidders should have successfully completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the above project. The description of an eligible bidder is contained in the Bidding Documents and Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act” for Lot No.1; and Lot No. 2 and 3 shall be using the Revised Implementing Rules and Regulations (IRR) of Republic Act 10531.
4. Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of RA 9184 or RA 10531.
5. A compulsory attendance during the Pre-Bid Conference is hereby enjoined. Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications.

6. For Lot No. 1, completion of work required is within Ninety (90) calendar days from receipt of the Notice to Proceed. For Lot No. 2 & 3, delivery of materials is within Thirty (30) calendar days from receipt of Purchase Order.
7. Bids shall be accompanied by a bid security payable to the procuring entity in the form of Cash, Cashier's check, and Manager's check amounting to 2% of the Approved Budget of the Contract.
8. Also, a valid PCAB License (Philippine Contractors' Accreditation Board) is required for the Housewiring Installation which specializes on Electrical work; Small B, Category C & D (size range, license category).
